

As the petitioner requests, we have sent the petition to the U.S. Department of State National Visa Center (NVC), 32 Rochester Avenue, Portsmouth, NH 03801-2909. The NVC processes all approved immigrant visa petitions that need consular action, including the collection of necessary forms and documents. It also determines which consular post is appropriate to complete visa processing. The NVC will then transfer the approved petition to the consular post once processing has been completed and an interview has been scheduled at the Embassy or Consulate.</p> <p>The NVC will contact the beneficiary of this petition with further information about immigrant visa processing steps.</p> <p>You should allow a minimum of 45 days for U.S. Department of State processing before contacting the NVC.
